The coating will retain its beading/ sheeting effect for at least 24 months.

Use the GYEON **Q<sup>2</sup>M CURE** maintenance spray, **Q<sup>2</sup>M BATHE+** shampoo or **Q<sup>2</sup>M WETCOAT** hydrophobic booster periodically. Let your detailer advise you on the best car care methods to achieve long lasting shine and protection.

**PLEASE NOTE THAT THIS WARRANTY IS VALID ONLY  
IF THE FOLLOWING CONDITIONS ARE FULFILLED:**

- Application of the coating was performed only by a GYEON Certified Detailer.
- The process was performed strictly in accordance with the rules of the manufacturer.
- The car was not washed in an automatic or commercial car wash.
- After the GYEON service, the vehicle has not been serviced by any other detailing company that is not approved by GYEON.
- Q<sup>2</sup>M Cure, Q<sup>2</sup>M WetCoat or Q<sup>2</sup>M Bathe+ has been used at least once every 3 months for maintenance purposes.
- This warranty is valid for 5 years from date of application, for vehicles that are 2 years old or newer, for vehicles that are over 2 years old and under 10 years old at the time of application, the warranty is valid for 2 years.

The warranty is valid only under the above listed conditions and does not cover any types of damage or failure other than those listed above. The warranty will not be accepted without the initial service invoice. GYEON will not accept any warranty claims from any vehicle users other than its owner on the

day of signing this document. The warranty period starts on the date of signing this document by the authorized detailer. GYEON will not be held responsible for damage caused by improper use of the vehicle, track use or any surface damage caused by accidents or vandalism. The warranty is not transferrable or valid for commercial vehicles. GYEON will not be held responsible for lost business, profits or for any losses or additional costs relating to submitting or for the duration of warranty claims.
